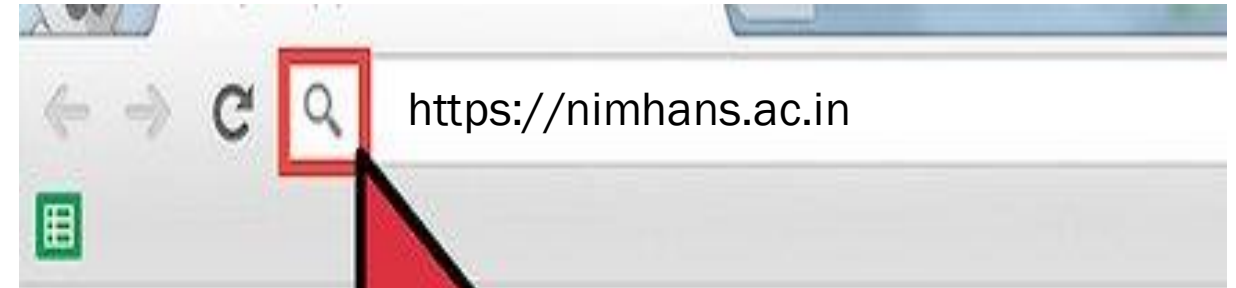

Step 1

In the address bar write the website name and click enter from your keyboard

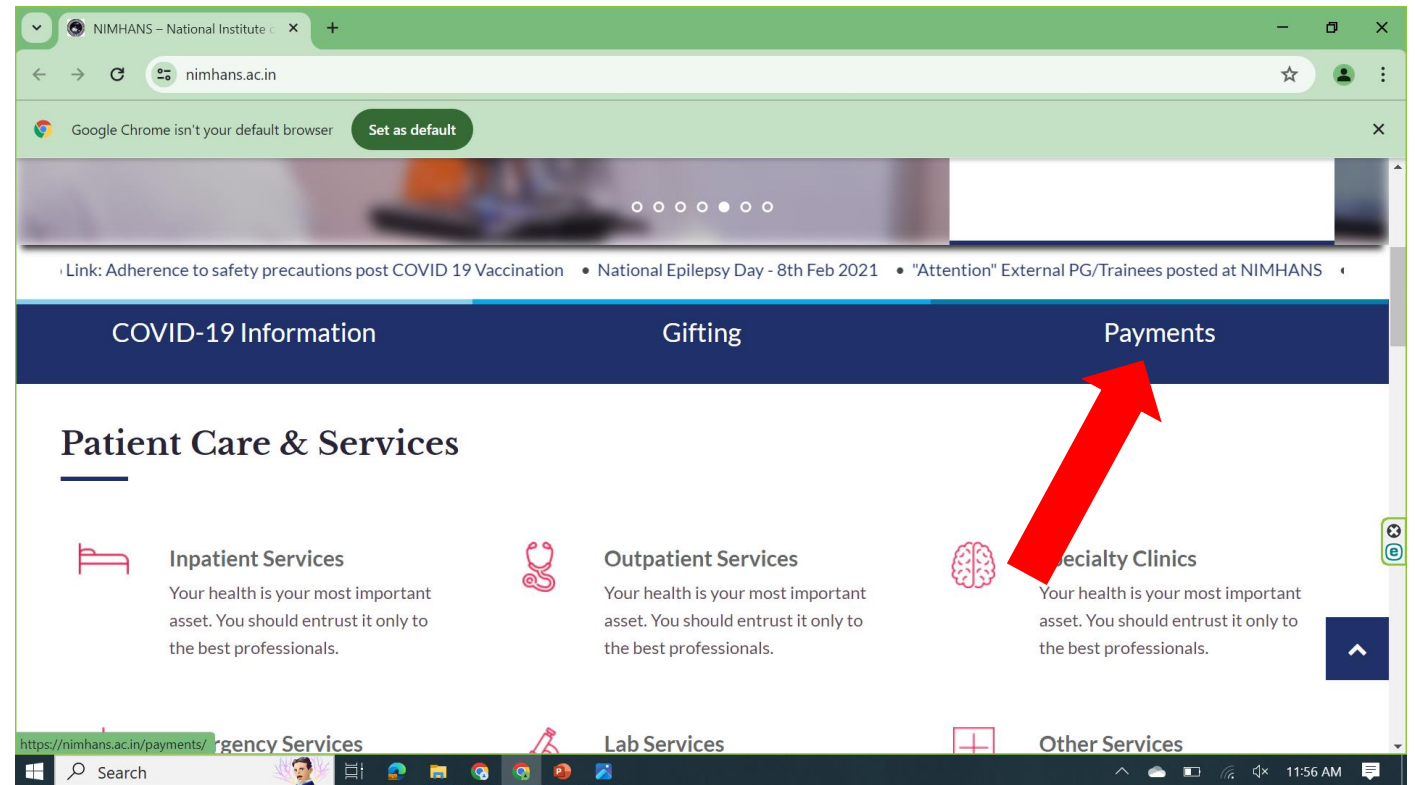
